SEASONAL STRUCTURE

All teams must be engaged in meaningful competition until March 1, 2022 – No teams may be eliminated from competition before this date.

U9 REPRESENTATIVE PROGRAMMING - 2022-23

Effective 2021-22, amendments to OHF Playing Regulations resulted in the elimination of all competitive (Representative) categories at U9. The implementation of this decision was deferred for one season.

Therefore, effective the 2022-23 season, the only categories permitted at U9 will be House League (HL), Local League (LL) and Minor Development (MD).

U9 PROGRAMMING - 2023-24

See OHF Bulletin 22-09

Moving forward, the OHF will continue towards full compliance with the Hockey Canada Player Pathways and will eliminate all forms of Streaming at U9 and below.

Effective 2023-24, the only categories permitted at U9 will be House League (HL) and Local League (LL).

The Ontario Hockey Federation is excited to announce player evaluation dates for Minor Hockey Associations for the 2022-23 hockey season. With the recommendation from its Members, the OHF Directors have approved the following player evaluation dates:

- U7-U11 will continue to follow OHF Playing Regulation G3 & G4 and the nationally approved Canadian Player Pathways.
- U12 and U13 will be held in the fall, following Labour Day.
- U14-U16, U18 AA and below Categories, and U21 will be held in the spring, in accordance
 OHF Playing Regulation G2, G5 and applicable LOR Playing Regulations. The first day for spring evaluations will be April 25, 2022.
- U18 AAA will be held in accordance with OHF Playing Regulation K.

Further information pertaining to seasonal structure (prep phase, tryout phase, development phase, playoffs, tournament start dates) as well as specific Playing Regulations will be identified and publicly released following the OHF Semi-Annual Meeting of Members, February 26, 2022. We trust this information provides sufficient information pertaining to spring 2022 ice contracts.

Re: 2022-2023 Seasonal Calendar Motions

At the OHF Semi-Annual meeting of the Members on Saturday, February 26, 2022, the OHF Playing Regulations for the 2022-2023 season were passed which included the following Seasonal Calendar amendments for Minor Hockey specifically:

- The first tryout date for U11 and U13 AAA Programming is the first Saturday following Labour Day. Each Association individually or as a collective are to provide Preparation Skates the Tuesday, Wednesday, Thursday and Friday for those Players that wish to participate.
- The U13 Player Pathway requirements for Preparation Skates (MHA must provide opportunity to 4 skates), Player Evaluations (3 evaluations skates before cuts are made with a skills, small area games and scrimmage), Development Phase, Regular Season Phase and Tournament Style Playoffs. Please see the attached U13 Hockey Canada Player Pathway. draft for reference.
- There are no tournaments for any programming held prior to September 30, 2022.
 - U11 and U13 AAA Programs may begin tournaments on September 30, 2022; and
 - o U11 and U13 AA and below can begin tournament October 7, 2022.
- All competitive (not MD, House League, Local League and Select) programming at U15 and above have a mandatory Development Phase for the first 24 days following Labour Day Monday with a maximum of 4 Exhibition Games during this time frame (September 6, 2022 to September 29, 2022).
- To host the OHF Championships the 4th weekend of April, April 21-23, 2023.
- Players at U12 and below in the 2021-22 season are Registered Participants of their previous season's Team up to and inclusive of Labour Day for the 2022-23 season.



These adaptations to the Regulations are in line with the philosophy to give children and family back their summers at all Divisions and Categories with a longer overall season with significant and meaningful competition for all teams until March 1 of the playing season.

At the Ontario Hockey Federation's Semi-Annual Meeting of Members held Saturday February 26, 2022, the following Notices of Amendment were approved by the Members of the OHF:

- 22-01 Notice of Amendment Regulation 1
- 22-02 Notice of Amendment Regulation C4
- 22-03 By-Law #42

Each approved Notice of Amendment has been attached to this bulletin for reference.

These Notices of Amendment focus on the OHF compliancy with the Hockey Canada Player Pathways at U9 and below. Since the inception of the U7 and U9 Player Pathways in 2017 the OHF maintained a two-stream structure of programming based on skill versus the desire of the customer. Specifically, Notice of Amendment 22-02 pertaining to Regulations C4 and the requirement to remove all forms of Streaming at U9 and below will come into effect for the 2023-2024 season. This will allow the OHF Members and Local Hockey Associations the next 18 months with the support of the OHF to transition programming from a two-stream model based on skill to a model of participation based on desire.

The OHF will be working with the Members and Local Hockey Associations on education of streaming and potential pilot opportunities during the 2022-2023 season that will work to test different approaches for full compliance during the 2023-2024 season.

Each Member will provide the OHF Directors every two months a report of their progress in transition to the removal of streaming at U9 and below for the 2023-2024 season.

In addition, the OHF has considered an application from the GTHL for an exemption from the removal of Select Hockey at U9 and below which was adopted for the 2020-2021 season. The OHF Directors have approved the following exemption from the OHF Regulations for the 2022-2023 season only:



The GTHL is granted a one (1) year exemption for the 2022-2023 season operate Select Hockey at U9 and below on the following conditions:

- 1. Non-Resident Players to the GTHL (Players that live outside of the GTHL jurisdiction in accordance to OHF Regulations) that were registered in the GTHL during the 2021-2022 at U8 and below are eligible to continue to participate as a grandfathered player in Select Hockey for the 2022-2023 season only. Note: This condition does not preclude players, U9 and above in the 2021-22 season, from participating in a Select program in the 2022-23 season.
- 2. Non-Resident Players to the GTHL (Players that live outside of the GTHL jurisdiction in accordance to OHF Regulations) that were not registered with the GTHL during the 2021-2022 season are not eligible to register with Select programming in the GTHL at U9 and below.

The OHF Directors in its support of the philosophies of the Hockey Canada Player Pathways, and the integrity of its By-Laws, Regulations, and Policies, note that such exemption be for the 2021-22 season only. Specifically, the OHF and its Members will be compliant with Notices of Amendment 22-01 and 22-02 for the 2023-2024 season.

Streaming – the process of providing unequal opportunities in regard to skill development, frequency of participation, and level of participation based on individuals' skill levels rather then their desires.

Tiering – the process of placing like skilled players with like skilled players to provide meaningful competition.

RATIONALE: Must include impact of change on your Member, other Member and the OHF both positive and/or negative.

Within the Hockey Canada U9 and below programming the focus of the Long-Term Athlete Development Model is on overall participant development of individual skills and player retention. The current system of programming within Minor Hockey based on only tiering does not provide equal opportunity for ice time based on the desire of the player and thereby limits development for many.

In order to align with the Long-Term Athlete Development Model the OHF during the past two Semi Annual Meetings of Members adjusted eligible Categories for U9 programming which removed Select Hockey and Representative Novice Hockey. To date these changes have not been implemented by all the



Members, however, in the investigation of implementation since February of 2021 the removal of certain terminology is only one part of the solution. The implementation of the Long-Term Athlete Development Model principles of player development regardless of skill and based on desire to participate needs to be implemented to reduce the current streaming of players based on their individual skill level at a specific point in time.

Tiering does not offend the Long-Term Athlete Development Model if equal development opportunity is provided to all.

The definition is proposed and expanded to include a definition of Tiering to provide clarity between the two terms and in order to adjust programming requirements at Minor Hockey to focus on participation and retention of players from U7 through to U11.

The Directors have the authority to approve Pilot Programs, other than any pilot that violates Article 2.1, 4, 42.5 and 42.6. Pilot proposals may be submitted by a Member(s) or Director with reasonable time for the Board to have meaningful consultation with the Member(s) affected prior to consideration. Any Pilot Program must meet the requirements of the Pilot Program Policy and have a defined start date, end date and evaluation process.

RATIONALE: Must include impact of change on your Member, other Member and the OHF both positive and/or negative.

With the ever-changing landscape that hockey administration faces the OHF and its Members need to have the flexibility to try new initiatives or concepts as evaluations without having to first amend the By-Laws or Regulations in a wholesale change. This wording provides clarity that this is an option versus it being a grey issue based on past practice. The Pilot Policy sets out requirements for pilot submissions and is built off of the Hockey Canada Pilot Policy.
