I understand that I am bound by the following OHF Regulations:

### F5 – Restriction on Team Officials Changing Associations

A person who is registered as a Team Official in one Season may not, without the consent of the Minor Hockey Association with which such person is registered as a Team Official, be registered or appear on the bench in the immediately following Season as a Team Official for a Team providing programming to Players of the same birth year as the current season. In the case of U18 AAA and/or any other mixed age team, this restriction also applies to Teams in the same age division. The consent of the Minor Hockey Association required by this Regulation F5 must be sought and granted by that previous Minor Hockey Association prior to the new Minor Hockey Association announcing, publicizing and appointing an individual. Permission must be provided in writing, signed by an Official of the Minor Hockey Association or be provided by e-mail sent by an Official of the Minor Hockey Association to the e-mail address of the Member Office. A Minor Hockey Association may withhold its consent in its sole and absolute discretion, except that the Board or a Special Committee may grant relief from this Regulation F5 in exceptional circumstances. The new Minor Hockey Association may not advertise (either in writing or orally) that a person who requires consent under this regulation will be a Team Official for that Minor Hockey Association, nor is that individual permitted to participate in tryouts for the new Minor Hockey Association unless written consent has been granted by either the former Minor Hockey Association, the Board or a Special Committee prior to the advertising and/or tryouts being conducted. Any new Minor Hockey Association that violates this provision will be fined \$1,000 and the Team Official will not be permitted to register with that Minor Hockey Association for that season.

### F6 – Team Official’s Commitment Form

Any individual committing to accept a Team Official position with a Minor Hockey Association for the following season should sign a Team Official Commitment Form confirming such commitment.

Any action to negate such commitment by the signatory, unless by mutual consent, will result in the signatory being ineligible for registration with any other Minor Hockey Association for the season for which the commitment has been made.

If the individual requires consent from their previous Minor Hockey Association as outlined in Regulation F6, such consent must be granted in writing prior to the individual signing the Team Official Commitment Form.





For the commitment to be enforced, the form must be filed by the Minor Hockey Association with the Member Office. The Member will begin accepting these forms on **February 15**.

If a Team Official signs a Team Official's Commitment Form with two or more Minor Hockey Associations, the Team Official's Commitment Form that is filed first with the Member Office will be deemed to prevail. The consent of a Minor Hockey Association required by this Regulation F6 must be provided in writing, signed by a Minor Hockey Association Official or be provided by e-mail sent by a Minor Hockey Association Official to the e-mail address of the Member Office. A Minor Hockey Association may withhold its consent in its sole and absolute discretion, except that the Board or a Special Committee may make a special ruling with reference to this Regulation F6.
